Subject 1 :Approval of the previous meeting minutes

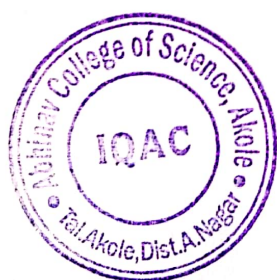


Subject 3: Student support and engagement programs

Subject 4: Infrastructure and safety audit.

Action Taken: A professional safety audit of all science laboratories (Chemistry, Physics, Biology) was conducted by Safety First Consultancy. The audit report highlighted the need for fume hoods in Chemistry labs and the installation of fire extinguishers in Biology labs. The necessary actions are being taken.
